HEALTHCARE

Greater Access to Care at Lower Costs

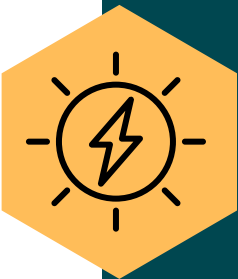
- Vermont's healthcare system could benefit from a simple yet transformational scope of practice reform. Scope of practice laws hinder highly trained healthcare professionals, such as Advanced Practice Registered Nurses, from delivering essential healthcare where patients desperately need their assistance.
- Vermont must also reject harmful legislation that imposes unnecessary regulations and poorly designed subsidies. Legislation imposing mandatory price floors should be opposed.



ENERGY

Embrace Energy Abundance and Reduce Energy Poverty

- Act 18 places unnecessary restrictions on energy development, driving up costs for consumers and limiting Vermont's energy independence. Repealing Act 18 will help unlock affordable energy solutions and promote a more competitive energy market.
- Affordable, reliable, and abundant energy sources are key drivers of economic opportunity. All sources of energy generation should be on the table to increase competition and reduce costs for Vermonters.
- Bottom-up innovations should be embraced, and reforms that reduce energy poverty should be prioritized. Top-down energy mandates should be rejected.



HOUSING REFORM

Address the Housing Crisis by Removing Barriers

- All harmful rent control policies and burdensome "clean energy" regulations should be rejected.
- Reforms to or the elimination of burdensome regulations and permitting processes, such as Act 250, and reforms of zoning laws restricting housing types, lot sizes, lot coverage, and more should be pursued.



TAX & REGULATORY REFORM

Protect Vermonters from Harmful Tax Increases

- Oppose any effort to increase taxes that burden families, businesses, and economic growth.
- Common-sense regulatory reforms that eliminate unnecessary red tape and promote a thriving economy.
